- \*In addition to the application, you must complete the SLA's require "Personal Questionnaire" (available on TEI's website).
- *After completing both forms* (the application AND the personal questionnaire), e-mail scanned version to compliance@teimports.com.
  - o Please make sure to copy orders@teimports.com on that e-mail.
- Send the hard copy documents to TEI's office:
  - o T. Elenteny Imports, 285 West Broadway, Suite 500, New York, NY 10013
- TOGETHER with those TWO COMPLETED DOCUMENTS, you must also send by e- mail or by paper, a copy of (1) New York State ID (e.g., driver's license or NY state residence id), and (2) Proof of Citizenship (e.g., Passport) or Green Card.

  Please send all these items together
- **TEI will notify you once the SLA has received the necessary forms**. At that point the SLA requires that YOU get fingerprinted.
